

# Licence for the Multi-source National Forest Inventory Raster Maps

## 1. General Information

The use of the Multi-source National Forest Inventory raster maps of 2009, 2011, 2013, and 2015 is restricted by the terms of use in this licence.

The producer of the material and the owner of the copyright and database protection of the material is The Natural Resources Institute Finland (Luke).

The Licensee is a natural or legal person or organization who makes use of the material covered by this licence.

The producer of the material does not charge any fee on the use of the material in compliance with this licence.

The source of origin and the date of the version of the material must be given when the material is used, as follows (where xx is 12 for the 2009 data, 13 for the 2011 data, 15 for the 2013 data, and 17 for the 2015 data): © Natural Resources Institute Finland, 20xx.

## 2. Terms of the Licence

### 2.1. Rights of Use
